Bruneian Entrepreneurs Gear Up Towards Greater Intra-ASEAN Trade

BANDAR SERI BEGAWAN, 17 March 2022 – 29 representatives from the Bruneian public and private sectors, *inter alia* the ASEAN Business Advisory Council (ASEAN-BAC), Darussalam Enterprise (DARe), National Chamber of Commerce and Industry (NCCIBD), Brunei Malay Chamber of Commerce and Industry (DPPMB), French Bruneian Business Association (FBBA), SME business owners and many other trade associations and business organizations in Brunei Darussalam, attended an outreach event on the ASEAN Trade Repository (ATR, available at https://atr.asean.org) and the ASEAN Solutions for Investments, Services and Trade (ASSIST, available at https://assist.asean.org/) on 15 March 2022. The event was organized by the EU-funded programme ASEAN Regional Integration Support from the European Union (ARISE Plus), in partnership and collaboration with ASEAN BAC Brunei and DARe, and held virtually.

Mr. Javed Ahmad, Chief Executive Officer of the Darussalam Enterprise (DARe), stated that "Trade facilitation is particularly important for the MSMEs hit hardest by the crisis. In the midst of this global crisis, international cooperation in trade facilitation will remain important to keep trade flowing. Such initiatives on the development of ASSIST and ATR are a demonstration of international collaboration between EU, ARISE PLUS and ASEAN Business Advisory Council".

The Hon. FDr. Ar. Siti Rozaimeriyanty DSLJ Haji Abd Rahman, Brunei Chair of ASEAN Business Advisory Council (ASEAN BAC), said "ASEAN BAC always emphasize on the importance of public-private sector engagement in driving regional economic integration and trade facilitation as our priority. We believe it has to go in tandem to achieve our AEC goals. After all, ASEAN has to remain in solidarity for collective action as we are set to become the fourth largest economy by 2030".

This Outreach Event was followed by the 'ASSIST Train-the-Trainers Workshop' on 16-17 March 2022. This training workshop has been designed to benefit and help participants to develop, organize and deliver training modules on how to use ASSIST. Participants of the training workshop are expected to become trainers and conduct future capacity building exercises on ASSIST to the benefit of their Bruneian colleagues, members of their trade associations/business organizations, and fellow entrepreneurs. 
